

**ORDINANCE NO. 2023-BC-O- 04**

**AN ORDINANCE OF THE  
MADISON COUNTY BOARD OF COMMISSIONERS  
ADOPTING A SCHEDULE OF FEES FOR THE MADISON COUNTY  
HEALTH DEPARTMENT**

**WHEREAS**, the Madison County Board of Commissioners (“Commissioners”) has previously adopted a schedule of fees pursuant to state statute and local ordinance for services provided by the Madison County Health Department (“Health Department”) to the citizens of Madison County; and,

**WHEREAS**, the Health Department has recommended a certain change to the current fee schedule in that a background check for a tattoo artist should be reduced from \$100.00 to \$10.00; and,

**WHEREAS**, the Commissioners concur with the Health Department’s recommendation regarding changes to the fee schedule.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Commissioners of Madison County, Indiana, that:

1. That the Schedule of Fees for the Madison County Health Department, attached hereto as Exhibit A, is hereby adopted.
2. That all prior fee schedules adopted by the Commissioners for services provided by the Health Department are hereby repealed.
3. That this fee schedule will become effective on April 3, 2023.
4. That the provisions contained herein do not effect, in any way, requirements for the application, enforcement, and collection of these fees as may be set forth in other ordinances of Madison County.


5. This Ordinance shall be in full force and effect from after its passage upon publication as required by law and pursuant to the effective date set forth herein.
