**JOINT RESOLUTION OF THE BOARD OF COMMISSIONERS
OF MADISON COUNTY and COMMON COUNCIL OF THE CITY OF
ELWOOD, INDIANA TRANSFERRING CERTAIN DUMP TRUCKS
FROM MADISON COUNTY TO CITY OF ELWOOD, INDIANA**

WHEREAS, I.C. 36-1-11-8 permits governmental entities to transfer personal property to other governmental entities by mutually acceptable terms; and,

WHEREAS, the Board of Commissioners of Madison County (hereinafter, "Madison County") is the owner of a 2016 Freightliner Dump Truck; and,

WHEREAS, the Vehicle Identification Number of the truck is: 1FVHG5CY4GHHF7690 and,


WHEREAS, Madison County wishes to sell, and the Common Council of the City of Elwood (hereinafter "Elwood") wishes to purchase, the 2016 Freightliner Dump Truck, which also has a snow plow and salt/sand spreader, for the amount of Seventy-Five Thousand Dollars (\$75,000.00).

NOW THEREFORE BE IT JOINTLY RESOLVED by the Board of Commissioners of Madison County and the Common Council of the City of Elwood that:


1. Elwood shall purchase from Madison County the 2016 Freightliner Dump Truck, VIN #1FVHG5CY4GHHF7690 for the amount of Seventy-Five Thousand Dollars (\$75,000.00) which amount shall be payable to Madison County on receipt.
2. Madison County makes no representation or warranty of any kind with respect to the 2016 Freightliner Dump Truck. As Elwood has inspected the 2016 Freightliner Dump Truck, it understands and agrees that no warranty is to be implied with respect to the condition, fitness, or particular purpose of the 2016 Freightliner Dump Truck.
3. Appropriate Madison County and Elwood department heads and agents are hereby authorized and directed to take necessary action and execute all documents necessary to transfer title for the 2016 Freightliner Dump Truck, VIN #1FVHG5CY4GHHF7690 from Madison County to Elwood.


